SECTION TWO OVERVIEW OF COMMENTS RECEIVED

2.1 PUBLIC REVIEW AND COMMENT PROCEDURES

CEQA requires public disclosure in an Environmental Impact Report (EIR) of all project environmental effects and encourages public participation throughout the EIR process. As stated in Section 15200 of the CEQA Guidelines, the purposes of public review of environmental documents are:

- (a) Sharing expertise,
- (b) Disclosing agency analyses,
- (c) Checking for accuracy,
- (d) Detecting omissions,
- (e) Discovering public concerns, and
- (f) Soliciting counter proposals.

Section 15201 of the CEQA Guidelines states that "Public participation is an essential part of the CEQA process." A public review period of no less than 30 days nor longer than 60 days is required for a Draft EIR under Section 15105(a) of the CEQA Guidelines. If a State agency is a lead or responsible agency for the project, the public review period shall be at least 45 days. As required under CEQA, the Revised Draft EIR was published and circulated for the review and comment by responsible and trustee agencies and interested members of the public. The public review period ran from April 4, 2006 through May 18, 2006. In addition, as described in Section One, a Partially Recirculated Revised Draft EIR was published by the County. The review period for the Partially Recirculated Revised Draft EIR ran from August 1, 2006 through September 14, 2006. All written comments received on the Revised Draft EIR and Partially Recirculated Revised Draft EIR are addressed herein.
