SUBJECT: PLACER COUNTY COMBINED GIVING CAMPAIGN

ACTION REQUESTED

Approve the attached resolution proclaiming September 2009 as "Placer County Combined Giving Campaign Month" and approve employee participation in the Campaign.

BACKGROUND

The Placer Combined Giving Campaign enters into its 17th year in September 2009. Traditionally, business, government, and the non-profit agencies come together in an effort to meet critical needs of the community through voluntary workplace giving. Last year, 175 Placer County employees generously contributed a total of over \$66,000 through the Campaign.

The County of Placer is again planning to utilize the County Intranet to minimize use of paper campaign materials. As with last year, the campaign will include agencies affiliated with Community Health Charities, Earth Share of California, The Metropolitan Arts Partnership, Placer Community Foundation, United Way California Capitol Region, as well as the Placer County Trust Fund for Animals, the Placer County Open Space – Placer Legacy Fund, and Employee Scholarship Fund.

FISCAL IMPACT

There are minimal costs to the County for staff time to run the campaign and payroll processing.

WHEREAS, Placer County has partnered with Community Health Charities, Earth Share, United Way California Capital Region, Metropolitan Arts Partnership, and Placer Community Foundation as organizations dedicated to public service through the efforts of many agencies and affiliates serving Placer County to meet the needs and interests of people of all ages. These community agencies play an important role in providing many services that help to reduce the ever increasing burden on local government resources; and

WHEREAS, Placer County Trust Fund for Animals provides resources to meet the needs of neglected, abused and adoptable animals within Placer County; and

WHEREAS, Placer County Open Space – Placer Legacy Fund ensures the protection and maintenance of open space lands and habitat in Placer County; and

WHEREAS, Placer County Employee Scholarship Fund provides for financial assistance to county employees in furthering their education; thereby increasing skills and knowledge in ways to further assist the citizens of Placer County; and

WHEREAS, the purpose of the Placer County Combined Giving Campaign is to provide a voluntary means by which county employees may join in efforts to participate in a variety of support and service programs.
