SUBJECT: Adoption of Salary Ordinance Establishing Contract Physician and Contract Chief Physician Pay Grades

REQUESTED ACTION AND RECOMMENDATION:

It is recommended to approve the attached ordinance that establishes the salary grades for the following:

- Contract Physician at Grade N20 (\$10,524.80-\$14,748.94 per month), and;
- Contract Chief Physician at Grade C13 (\$11,568.27-\$14,062.53 per month)

BACKGROUND:

The California Public Employees Retirement System (CalPERS) governs the manner and types of compensation that are reported to CalPERS for earnings and service credit for retirement and actuarial determinations. As part of these regulations, CalPERS requires the adoption of salary ordinances by the governing legislative body. Further, CalPERS requires that salaries be published on an established salary schedule.

In compliance with the CalPERS rules and regulations, the pay ranges recommended for adoption reflect the salaries that were in place at the time that the contracts were originally established. By adopting these pay ranges; there will be no change in any of the costs associated with the current physician contracts.

FISCAL IMPACT:

There is no fiscal impact. The proposed ordinance change is cost neutral in that it places current contract physicians on a published salary schedule but does not change their pay rate or contract.
