SUBJECT: Approve the Renewal of a Blanket Purchase Order Awarded from a State of California Competitive Contract with Voyager Fleet Systems, Inc. for Credit Card Fuel Purchases in the Maximum Amount of \$550,000.00

**ACTION REQUESTED**

Approve the renewal of a Blanket Purchase Order (BPO) awarded from a State of California competitive contract with Voyager Fleet Systems, Inc. of Houston, Texas for credit card fuel purchases in the maximum amount of \$550,000.00, and authorize the Purchasing Manager to sign the resulting BPO.

**BACKGROUND**

Voyager fuel credit cards, administered by the Department of Public Works (DPW), are used for fueling County owned and lease vehicles when staff is unable to utilize one of the County Card Lock fuel facilities located within the Auburn, Rocklin/Loomis, and Roseville/Lincoln areas. Voyager was awarded a contract by the State of California through October 31, 2011, as a renewal of a competitive bid. DPW administers the County's fuel card program with Voyager and requests a one-year renewal of BP017273 with Voyager. Purchasing Policy Manual Section 1.3(e)(3) permits contracting with a vendor that was awarded an agreement by another public agency as the result of a competitive process without further competitive bidding by Placer County.

There are significant advantages to using the Voyager system. First, drivers may purchase fuel at most service stations nationwide. Voyager consolidates all of these charges into one monthly statement to DPW and County departments reimburse DPW for card usage. Second, the Voyager system interfaces with the County's "Fleet Anywhere" fleet and fuel management system. This enables the County departments to use the Voyager cards at the County's Card Lock fuel facilities; thus reducing the number of Card Lock fuel cards required. Finally, the County is exempt from federal excise tax and the Voyager system removes this tax from each monthly invoice before billing the County. This saves the County \$0.184 per gallon for gasoline fuel and \$0.244 per gallon for diesel fuel.

**FISCAL IMPACT**

The BPO resulting from this recommendation will total \$550,000.00 and will be effective from November 1, 2010 through October 31, 2011. DPW's Fiscal Impact Statement is attached.
