**ACTION REQUESTED**

Approve appropriation of \$700 in Revenue Sharing monies to the Placer Care Coalition 12<sup>th</sup> Annual Raising Spirits event to benefit the homeless and those in need within our community, as requested by Supervisor Weygandt (\$250), Supervisor Holmes (\$200) and Supervisor Uhler (\$250).

**BACKGROUND/COMMUNITY BENEFITS:** In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help fund the Placer Care Coalition's *Raising Spirits* annual fundraising event on April 22, 2012. The Placer Care Coalition was formed in 2001, bringing together Roseville Home Start, the Lazarus Project, St. Vincent de Paul, and other charitable organizations in the community. The Coalition Board is made up of representatives from those agencies, plus several members "at large", along with volunteers who receive no salaries. The Placer Care Coalition offers a variety of services to those needing help throughout South Placer County, including shelter for homeless families, social services, food, transportation and programs for the elderly and singles in transition. Requests for help this year have increased in Roseville/South Placer, and the funds designated for this event will be divided evenly between the Coalition's agencies to help provide these vital services to the community.

Dear Placer County Board of Supervisors


**We greatly appreciate your support in the past years for Placer Care Coalition's Raising Spirits.** This year, with the increasing needs in Placer county, we are again seeking your sponsorship for our annual "*Raising Spirits*" wine and food tasting event, scheduled for **April 22, 2012 at the Morgan Creek Country Club in Roseville.** The success of this event depends heavily on the support of our sponsors. As you know, the Placer Care Coalition, Inc. is a non-profit organization that was formed in January 2001, bringing together Roseville Home Start, (providing shelter for homeless families), the Lazarus Project (a transitional program for single adults), St. Vincent de Paul (providing social services, dining room, food locker, and thrift store for the elderly and those in need), and What Would Jesus Do? (feeding the homeless, providing transportation and social services).

The Placer Care Coalition, Inc. board is made up of representatives from the four agencies plus several members at large. The efforts of all these organizations reach out to all of South Placer County. There are no boundaries for those in need. Churches and other agencies, including the police department, refer people in need to the above four organizations to provide help. The Coalition is made up of all volunteers who receive no salaries and thus we have no administration costs.

Our goal is to raise \$75,000. The price of a ticket is \$40 or two for \$75 prior to April 1, 2012. There will be a silent auction, live auction and raffle. Money raised from this event will be divided evenly between the four agencies. *We are aware of the many requests for help this year, but the need in Roseville/South Placer also is real and has increased over the past year.*
