SUBJECT: Approve the Award of Competitive Bid No. 10158 to Clean Sweep Environmental for Street Sweeping and Vactor Services in the Maximum Amount of \$65,000.00

ACTION REQUESTED

Approve the award of Competitive Bid No. 10158 to Clean Sweep Environmental of Rocklin for street sweeping and vactor services in the maximum amount of \$65,000.00, and authorize the Purchasing Manager to sign the resulting Blanket Purchase Order (BPO).

BACKGROUND

The Department of Public Works Road Maintenance Division (DPW) requires an annual blanket purchase order for street sweeping and vactor services on an as-needed basis for Eastern and Western Placer County.

The Procurement Services Division solicited competitive bids for street sweeping and vactor services on behalf of DPW. Thirteen bidders were notified electronically of Invitation for Bid (IFB) No. 10158 which was also posted on the County's website. A total of four bids were received. The bids were evaluated in accordance with the terms and conditions of the IFB. Clean Sweep Environmental is a registered Placer County local vendor and submitted the lowest responsive bid. The department has contracted with this vendor in the past and indicates that services have been good. A complete bid evaluation is submitted as Attachment A.

FISCAL IMPACT

Upon your Board's approval, a BPO will be awarded to Clean Sweep Environmental in the maximum amount of \$65,000.00 for the period of April 1, 2012, through March 31, 2013. The Department of Public Works' Fiscal Impact Statement is attached (refer to Attachment B).
