ACTION REQUESTED

Approve the appointment of John Bergmann, as requested by Supervisor Montgomery.

BACKGROUND

The Placer County Board of Supervisors, on July 25, 1995, approved appointment of an interim Board of Directors for the North Lake Tahoe Resort Association, consistent with the recommendations of the Master Plan Steering Committee. Following interim appointments by the Board of Supervisors, the North Lake Tahoe Resort Association Board of Directors was to become the controlling agency.

The FY 2003/04 contract with the North Lake Tahoe Resort Association called for Placer County to appoint: One at-Large member to the NLTRA Board of Directors – Four year term, with the terms beginning November 2003. Six members to the NLTRA Infrastructure Committee – Two year term per bylaws of the NLTRA Infrastructure Committee, with the terms beginning November 2003. The committee meets the last Monday prior to the first Wednesday of the month at 1:30 p.m., at the Tahoe City Public Utility District Board room.
