**ACTION REQUESTED**

Approve the appointment of Richard Lewis to Seat #9 (representing Physically Disabled).

**BACKGROUND**

The purpose of the Building Appeals Board is to hear and determine appeals from Code interpretations of the Building Inspector. The Appeals Board has the authority to determine the suitability of, and authorize the substitution of materials and types of construction equipment matters pertaining to the construction industry, and promulgate reasonable rules and regulations for conducting its hearing and meetings. The Appeals Board is comprised of nine (9) members appointed by the Board of Supervisors (not official of County), who are qualified by experience and training to pass on matters pertaining to building construction; two members serving 2 year terms, three members serving 4 year terms, and 2 members, representing Fire Officials and physically handicapped, serving 4 year terms. Meetings are scheduled as necessary to hear appeal requests.
