BACKGROUND/COMMUNITY BENEFITS

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help support the Placer Land Trust's *8th Annual Placer Conservator Award Ceremony*, honoring Alex Ferreira. Placer Land Trust presents the Placer Conservator Award each year to an individual, or organization that enriches the quality of life in Placer County through resource conservation, and Alex embodies this spirit. Alex was a farmer before becoming a politician, maintaining a dairy, vineyard and winery, but it was through his position as an elected official that he made a significant contribution towards protecting Placer County's open space, particularly agricultural lands. Alex held his first elected seat on the Nevada Irrigation District Board in the late 1960's, spent 24 years on the Placer County Board of Supervisors, and currently sits on the Board of the Placer County Water Agency and the Wildlife Heritage Foundation. The funds designated towards this event will help support the cost of the ceremony, allowing proceeds from the event to go directly towards Placer Land Trust's efforts to continue Alex's legacy, and to the fight to protect the rural economy and quality of life by and permanently preserving agricultural farms, ranches and open spaces in Placer County.
