

**Subject:** Marijuana Suppression Program Grant

**Action Requested**

1. Adopt a Resolution authorizing the Sheriff to execute a grant application with the Board of State and Community Corrections (BSCC) Marijuana Suppression Program (MSP) in the maximum amount of \$186,494;
2. Approve a Budget Revision to increase revenue and expenditures for acceptance of the BSCC grant to fund one Detective assigned to the Marijuana Eradication Team from October 1, 2012 to September 30, 2013, with no additional net county cost.

**Background**

The BSCC MSP grant was first awarded to the Placer County Sheriff's Marijuana Suppression Program in 2010 in the amount of \$275,000. Funding was received for the second year (2011) in the amount of \$230,236. Additional funding is now available for the third year (2012) in the amount of \$186,494. The overall goal of the MSP is to suppress illegal marijuana cultivation, trafficking, sales, and use in Placer County. The Sheriff's Office believes realization of these objectives will directly result in decreased drug availability and improved public safety throughout the community.

**Fiscal Impact**

FY 2012-13 BSCC grant will be used to fund one full-time Detective position for a period of one year, including overtime costs for the Marijuana Eradication Team, flight hours, and training. There is no fiscal impact to the General Fund with this action.

NOW, THEREFORE, BE IT RESOLVED that the Sheriff is authorized on behalf of this Governing Board to execute the grant application for FY 2012-13 funding, commencing October 1, 2012 to September 30, 2013 and sign the Grant Agreement with the BSCC, including any amendments or modifications thereafter.

BE IT FURTHER RESOLVED that federal grant funds received hereunder shall not be used to supplant expenditures controlled by this body.

BE IT FURTHER RESOLVED that the implementing agency/organization and partnering entities agree to abide by the statutes and regulations governing the federal Justice Assistance Grant Program as well as the terms and conditions of the Grant Agreement as set forth by the BSCC.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors approves the grant application between Placer County Sheriff's Office and the Board of State and Community Corrections in the maximum amount of \$186,494 and authorizes Sheriff-Coroner-Marshal, Edward N. Bonner, to execute the grant application.
