The Developmental Disabilities Area Board III is one of 13 area boards in California created by state law to advocate on behalf of individuals with developmental disabilities. The Board is given the responsibility to pursue the legal, civil and service rights of persons with developmental disabilities. The Area Board III consists of one member appointed by each of the ten County Board of Supervisors included in Area Board III and five appointees by the Governor. The ten counties included in the Area Board III include Alpine, Colusa, El Dorado, Nevada, Placer, Sacramento, Sierra, Sutter, Yolo and Yuba Counties.
