SUBJECT: Recommendation to Approve a Blanket Purchase Order with Maita Ford.

ACTION REQUESTED

Approve a blanket purchase order with Maita Ford of Auburn in the maximum amount of \$53,000.00 and authorize the Purchasing Manager to sign the resulting BPO.

BACKGROUND

A number of departments require Original Equipment Manufacture (OEM) parts for their vehicles and heavy equipment. Availability, close geographic proximity, and the ability to deliver in a timely manner are essential elements of these agreements. Additionally, OEM parts may only be available from one source in an area. Section 1.3 of the Purchasing Policy Manual permits an exception to the competitive bidding process for materials and parts of this nature.

FISCAL IMPACT

Most of the BPOs for this type of commodity are under the \$50,000.00 limit and fall within Procurement's contracting authority. However, the agreement with Maita Ford in the amount of \$53,000.00 used by Public Works requires your Board's approval. This agreement will be effective from April 1, 2006 through March 31, 2007. There is sufficient funding in DPW's budget for these expenditures.
