## ACTION REQUESTED / RECOMMENDATION

Adopt a Resolution authorizing the Director of Public Works to execute an agreement with the Federal Transit Administration (FTA) for Section 5307 Urbanized Formula Funds for Placer County Transit (PCT) Preventive Maintenance and Americans with Disabilities Act (ADA) transit service.

## BACKGROUND / SUMMARY

Placer County has been allocated \$435,000 in FTA 5307 funds this year by SACOG. This is the third year that Placer County has received a share of the urbanized formula transit funds. A much larger portion of Placer County Transit's service area has become urbanized, as defined by the Census Bureau, making the County eligible for more transit funds. The FTA 5307 urbanized funds can be used for capital purchases, preventive maintenance or ADA transit service. Placer County will use the funds for preventive maintenance on the PCT bus fleet and the ADA transit service that is contracted to PRIDE Industries. In order to receive the funds, the Department of Public Works (DPW) must execute a standard agreement with the FTA.

## ENVIRONMENTAL

This project is statutorily exempt from CEQA pursuant to Public Resource Code 21080(b)(10), as it is a project to provide passenger service. These activities are also categorically exempt pursuant to NEPA requirements.

## FISCAL IMPACT

FTA 5307 is an ongoing source of revenue annually for Placer County Transit. These funds are budgeted in the FY 2006/2007 Placer County Transit budget. These funds represent 8% of the Placer County Transit budget for 2006/2007.
