## **ACTION REQUESTED / RECOMMENDATION**

Approve a Resolution authorizing the Director of Public Works to award and execute the construction contract for the Auburn Ravine/Lincoln Way Curb Relocation Project to the responsible low bidder up to an amount of \$160,000 with County Counsel review of the necessary bonds and insurance, and authorize the Director of Public Works to execute contract change orders up to 10% of the contract amount.

## **BACKGROUND / SUMMARY**

The Auburn Ravine/Lincoln Way Curb Relocation project proposes to widen the existing right turn lane on northbound Auburn Ravine Road at Lincoln Way in Auburn. This widening will alleviate the traffic congestion that occurs at this intersection. Public Works is ready to proceed with construction of this project and is seeking authorization from the Board to award a contract.

## **ENVIRONMENTAL**

This project is Categorically Exempt from the provisions of CEQA per Section 15301, Existing Facilities. A Categorical Exemption was filed with the Placer County Recorder's Office on December 27, 2006. A Notice of Exemption was filed with the Placer County Recorder's Office on January 3, 2007.

## **FISCAL IMPACT**

The total project costs are estimated at \$160,000 for Auburn Ravine/Lincoln Way Curb Relocation Project and will be funded with Traffic Mitigation Funds. Construction is scheduled for Spring 2007. There is sufficient funding in the 2006/2007 Fiscal Year Budget for this work.
