**ACTION REQUESTED**

Approve a Resolution in support of the "Reno Tahoe Odyssey Relay Run Adventure" to be held on June 29<sup>th</sup> and 30<sup>th</sup>, 2007 around Lake Tahoe, passing through Placer County on June 29<sup>th</sup>.

**BACKGROUND**

As in previous years, the Board is again being asked to endorse the Reno – Tahoe Odyssey Relay Run Adventure. This event is scheduled to take place on June 29-30, 2007 and includes several teams of 12 runners competing in a 178-mile relay run course. The course begins in Reno, winds through the mountains to Truckee, travels Highway 89 to Tahoe City and further along to the west shore of Lake Tahoe to South Lake Tahoe. The course then returns to Nevada, traveling through Genoa, Carson City, and Virginia City before returning to Reno. The course is divided into 36 segments. One runner runs a segment of the course, while the other runners on the team ride along in 2 vans (6 to a van). The relay begins in Reno on Friday June 29<sup>th</sup>. The teams each start at different times between 9:00 a.m. and 3:00 p.m. One runner on each team will be running continuously until the teams complete the course. There are expected to be between 75 to 100 teams of runners. A portion of the net proceeds from this event will benefit the three local charity organizations of the Angel Kiss Foundation, Avon Foundation's Need For Speed Against Domestic Violence and the Tahoe Pyramid Bikeway. In addition, the event will showcase the many attractions that exist in the Reno – Lake Tahoe region and will promote Squaw Valley, Tahoe City and other locations and businesses in Placer County.

## **INTERAGENCY COORDINATION AND NOTIFICATION**

The organizers of this relay have worked with several local agencies for the necessary permits and approvals to safely conduct this event. This event does not close any roads and will not block or impede traffic on county roads. The runners will run along the shoulder of the roads and are required to comply with all traffic rules. In addition, as with the event last year, the organizers have worked closely with Caltrans, the California Highway Patrol, Placer County Public Works, Placer County Parks Division, the U.S. Forest Service and the Tahoe City PUD to obtain a special event encroachment permit to use Cabin Creek Road as a parking area for team vans, use of electronic message boards, and requiring the team vans to display signs that warn other drivers about the runners. Placer County will also be provided a certificate of insurance, liability insurance and liability release forms signed by each runner.

**WHEREAS**, Eric Lerude, on behalf of the Reno Tahoe Odyssey Relay Run Adventure, has applied to Caltrans for a Temporary Encroachment Permit to conduct a special running relay event around Lake Tahoe called The Reno Tahoe Odyssey Relay Run Adventure; and

**WHEREAS**, this relay event benefits two causes, The Angel Kiss Foundation dedicated to helping families with children who are being treated for cancer and Tahoe Pyramid Bikeway which is a non-profit endeavor to build a foot and bicycle path along the Truckee River; and

**WHEREAS**, the Reno Tahoe Odyssey Relay Run Adventure will travel along State Highway Route 89 on June 29, 2007 without closing any roads or restricting traffic. The course will enter Placer County just south of Truckee and exit into El Dorado County just below Homewood during legs 9-13 of the designated route.

**NOW, THEREFORE, BE IT RESOLVED**, that the Placer County Board of Supervisors supports the Reno Tahoe Odyssey Relay Run Adventure and requests that it be conducted per the terms and conditions set forth by Caltrans in their Encroachment Permit to maintain the safety of the motoring public.
