I am writing to request appointment to the North Tahoe Site/Design Review Committee (NTSDRC). This committee has experienced turnover in recent years and it is my understanding that there are presently several open seats. At the encouragement of Allen Breuch of Placer County Community Development Resource Agency and to serve the North Tahoe Community, I am applying to serve on this committee.

I have been working on real estate development projects in the Tahoe area as a land use planner and project manager since 1998. Over the past four years I have operated a small business located in Tahoe Vista, providing real estate development and land use consulting services primarily in Tahoe Region. Through these years I have worked closely with Placer County staff and appeared before the NTSDRC numerous times.

Originally I moved to Lake Tahoe from Southern Oregon, after working on a fifty-year Regional Vision Plan with Jackson and Josephine Counties. It was my first professional experience after completing studies at Southern Oregon University for a dual major in Environmental Studies and Geography. The project provided insight into the challenges of multi-jurisdictional policies and addressing the interests of divergent stakeholders, a prelude to the challenges I have since experienced firsthand in the Tahoe Basin.
