### **ACTION REQUESTED**

Adopt a resolution authorizing the approval of contract #07-0443 for Sudden Oak Death Prevention and Detection activities with the State Department of Food and Agriculture allowing for reimbursement from the State for up to \$36,168.50.

### **BACKGROUND**

The California Department of Food and Agriculture (CDFA) provides for reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs.

### **ENVIRONMENTAL**

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

### **FISCAL IMPACT**

This contract represents \$36,168.50 in reimbursement to offset the Agriculture Department's impact to the General Fund. Funding for this contract is in the 07/08 Agricultural Commissioner's Budget.
