SUBJECT: Approve the Award of a Purchase Order, Awarded from a National Joint Powers Alliance Competitive Contract, to Holt of California for One Caterpillar 140M Motor Grader in the Amount of \$309,654.66

ACTION REQUESTED

Approve the award of a purchase order (PO), awarded from a National Joint Powers Alliance (NJPA) competitive contract, to Holt of California of Pleasant Grove for one Caterpillar 140M motor grader in the amount of \$309,654.66, and authorize the Purchasing Manager to sign the resulting PO.

BACKGROUND

On October 18, 2007, NJPA awarded competitive Contract No. 100907 for heavy, agriculture, snow, utility equipment and related accessories and supplies, as a result of NJPA's competitive Invitation for Bids No. 100907, to Caterpillar Inc. Holt of California is Caterpillar's local distributor offering NJPA pricing. Placer County Department of Public Works (DPW), Fleet Services has requested to purchase one motor grader like the unit awarded by NJPA, using the base and optional pricing from the NJPA competitive bid. The motor grader will be used during road maintenance projects. Under the terms of NJPA's contract with Caterpillar, Placer County's price for the motor grader is \$309,654.66, which is \$35,916.34 less than DPW Fleet Services' market estimate for this machine. In accordance with the Purchasing Policy Manual Section 1.3 (e)(3), County policy permits contracting with a vendor that was awarded an agreement by another public agency as the result of a competitive process without further competitive bidding by Placer County.

FISCAL IMPACT

The purchase order with Holt of California resulting from this recommendation will total \$309,654.66 for one Caterpillar 140M motor grader. DPW's Fiscal Impact Statement is attached.
