ACTION REQUESTED:

This is to request the appointment of Planning Commissioner Larry Farinha to fill the 13th seat of the Wastewater Advisory Committee.

BACKGROUND:


The purpose of the Wastewater Advisory Committee is to make recommendations to the Environmental Health Director regarding ordinance adoption and revisions, review methods, techniques and materials for on-site sewage treatment and disposal, and policy issues. The Committee is composed of 13 members representing the following: Planning Commissioner or Member of the Board of Supervisors; Placer County Architects, Geologists, Engineers, and Surveyors (P.A.G.E.S.); Academia; Placer County Association of Realtors; Placer County Facility Services; Septage Pumper; Septic Tank Manufacturers Association; Building Industry; On-Site Sewage Disposal Consultant; Contractors/Installers' Association; Public-at-Large; Environmental Consultant; Manufacturers' Association (to be appointed by the Board of Supervisors). The term is for two years.

On October 25, 2007, Jill Pahl, Director of Environmental Health, requested that the Planning Commission recommend a Planning Commissioner to fill the vacant position for a two-year term on the Wastewater Advisory Committee. Larry Farinha volunteered to be on this Committee and the Planning Commission recommended unanimous approval.

FISCAL IMPACT:

There is no compensation for service on the Wastewater Advisory Committee; therefore there will be no fiscal impact.
