**SUBJECT:** Community Oriented Policing Services (COPS) Technology Grant Acceptance

**ACTION REQUESTED**

Approval is requested to accept the grant in the amount of \$1,590,010 for continuation Phase III of the Placer County Regional Communications Network Radio Infrastructure and Upgrade and to authorize the County Executive and Sheriff-Coroner-Marshall to execute the grant acceptance documents. This grant has been included in the Final Budget.

**BACKGROUND**

The COPS 2008 Technology Grant is the vehicle to accept and implement the Federal Earmark approved during the Federal FY 2007/2008. Placer County was notified in December 2007 that a Federal earmark had been approved for the Law Enforcement Communications Infrastructure and Upgrade project. Your Board approved the overall project plans submitted by Administrative Services in February 2003. Documents were received in May 2008 from the COPS office to submit this sub-phase of the project for final review and approval to implement the earmark awarded. The final approval amount for the grant award is \$1,590,010. Placer County Sheriff's Office was notified of this award on September 15, 2008 and the requirement that acceptance and authorization for the grant was due.

This grant will pay for a portion of the costs related to Phase III of this project. Your Board's approval is needed to accept the grant in the amount of \$1,590,010 and authorize the County Executive and Sheriff to execute the grant award document.

**FISCAL IMPACT**

There are no matching requirements to the Sheriff's budget Related to this grant. The grant has been included in the FY 2008/2009 Final Budget. The Grant covers all costs for equipment and improvements as outlined in the Master Fixed Assets and approved by your Board in the Final Budget.
