SUBJECT: Approve the Renewal of Blanket Purchase Order No. 15532 as a Result of Competitive Bid No. 9667 with Black Box Network Services for NEC Brand Telephone System Parts in the Maximum Amount of \$75,000.00

ACTION REQUESTED

Approve the renewal of Blanket Purchase Order No. 15532 as a result of Competitive Bid No. 9667 with Black Box Network Services of Bridgeville, PA for NEC Brand Telephone System Parts in the maximum amount of \$75,000.00, and authorize the Purchasing Manager to sign the resulting blanket purchase order.

BACKGROUND

The Administrative Services' Telecommunications Division has an ongoing requirement to purchase NEC brand telephone system parts on an as-needed basis. Your Board approved the award of Competitive Bid No. 9667 to Black Box Network Services on April 3, 2007. The bid allowed for an initial one-year contract with subsequent one-year renewal options. On March 25, 2008 your Board approved the renewal of the BPO at the same pricing and terms as the previous year. The current BPO with Black Box Network Services will expire on March 31, 2009. Black Box Network Services has agreed to a second one-year renewal at the same pricing, terms and conditions as last year. Telecommunications reports that Black Box Network Services has provided satisfactory service to the County.

This recommendation is made in accordance with the Purchasing Policy Manual (PPM) Section 1.3(o) and the bid terms and conditions, which allow renewal a contract when it is in the County's best interest based on satisfactory service and reasonable pricing.

FISCAL IMPACT

The new BPO will be in the maximum amount of \$75,000.00 for the period April 1, 2009 through March 31, 2010. Administrative Services' Fiscal Impact Statement is attached.
