SUBJECT: Approve the Renewal of Competitively Awarded Blanket Purchase Order No. 15864 with DFC, Inc. Doing Business as Advanced Helicopter Services for Helicopter Inspection and Maintenance Services in the Maximum Amount of \$72,000.00

**ACTION REQUESTED**

Approve the renewal of competitively awarded Blanket Purchase Order (BPO) No. 15864 with DFC, Inc. doing business as Advanced Helicopter Services of Auburn for helicopter inspection and maintenance services in the maximum amount of \$72,000.00, and authorize the Purchasing Manager to sign the resulting BPO.

**BACKGROUND**

The Sheriff's Department requires a contract with a qualified contractor to perform helicopter maintenance, repair, component installations and Federal Aviation Administration required inspections for the department's current 1971 Bell OH58A and 2008/09 A-Star 350B3 helicopters. On June 24, 2008, your Board approved the award of competitive Bid No. 9813 with Advanced Helicopter Services for helicopter inspection and maintenance services, and authorized the Purchasing Manager to sign the resulting BPO in the maximum amount of \$72,000.00 for the Sheriff's Department.

Advanced Helicopter Services has agreed to renew for another year at the exact same pricing and terms as their original BPO. The Purchasing Policy Manual, Paragraph 1.3 (o), allows for the renewal of this contract based on satisfactory service and reasonable pricing offered by the vendor. The resulting BPOs shall be effective for the period of July 1, 2009 through June 30, 2010.

**FISCAL IMPACT**

Since the Department intends to sell the Bell OH58A as soon as possible after the A-STAR 350B3 is mission ready, the requested BPO maximum amount is the same as the previous BPO. The resulting renewal BPO will provide helicopter inspections and maintenance services for the Placer County Sheriff's Department in the maximum amount of \$72,000.00. BPO Renewal for Advanced Helicopter for the period 07-01-09 – 06-30-10

Funds are included in the current FY 2009/2010 Sheriff's Department budget for these expenses resulting in no additional fiscal impact to the General Fund.

The Advanced Helicopter BPO is used by the Air Operation's Unit for aviation maintenance and inspection services. The request for the renewal BPO is for \$72,000 based on history and projected engine replacement, fitting time and certain maintenance that is required based on the number of hours flown. The majority of these services are not an option. They are required for officer safety by maintaining the helicopter properly.
