ACTION REQUESTED / RECOMMENDATION

Approve a Budget Revision to amend the Public Works Fleet Services Master Fixed Asset List for the 20009/2010 Fiscal Year to reflect a \$10,000 increase to the Orpak Fuel Management System Upgrade; and authorize the Purchasing Manager to issue a Change Order to Purchase Order #19-2009-PO090101 issued to Orpak USA Inc. adding \$10,000 to the original purchase amount of \$44,687.93 for a total of \$54,687.93.

BACKGROUND / SUMMARY

In 2001, DPW/Fleet Services purchased and installed an automated fuel system for the Auburn Service Station from RNI, (now ORPAK USA). On May 26, 2009, the Board of Supervisors approved the addition of a Fuel system Hardware/Software upgrade to improve reliability, minimize maintenance difficulties, and extend the life of our ORPAK system by 4 to 5 years. In preparation for this upgrade, it was discovered that the existing conduit at the Auburn Service Station cannot be used to accommodate cabling. In order to proceed with this upgrade, Wireless Radio Ethernet equipment will need to be used for an additional cost of \$10,000.

ENVIRONMENTAL

The following action is not a project as defined by Public Resources Code Section 21065, and is therefore exempt from environmental review under CEQA.

FISCAL IMPACT

The additional cost to the automated fuel system upgrade will be funded by Fleet Services Fixed Asset Reserves. Currently, there is \$919,088 in the Fleet Fixed Asset Reserves. Purchase now will allow for installation in August, 2009.





