Subject: **SMD 1 WASTEWATER TREATMENT PLANT UPGRADE AND
EXPANSION: CLEAN WATER STATE REVOLVING FUND FINANCIAL
ASSISTANCE APPLICATION**

ACTION REQUESTED / RECOMMENDATION: Staff recommends that your Board adopt the attached Resolution to:

1. Designate the Director of Facility Services as the authorized representative to sign and file for a Financial Assistance Application from the State Water Resources Control Board;
2. Authorize the Director of Facility Services to certify that the Agency has and will comply with all applicable State and Federal statutory and regulatory requirements related to any financing or financial assistance received from the State Water Resources Control Board; and,
3. Authorize the Director of Facility Services to negotiate and execute a financial assistance agreement and any amendments or change orders thereto upon review and approval by Risk Management and County Counsel, and certify financing agreement disbursements.

BACKGROUND: On March 10, 2009, your Board approved consulting agreements for preliminary design of the Sewer Maintenance District 1 (SMD 1) Wastewater Treatment Plant Upgrade and Expansion Project (Project). The preliminary design is now complete, and, as described in other memos on this agenda, staff recommends moving forward with final design and environmental review.

The estimated cost for the Upgrade Project is \$87 million. Obtaining funding at this level will be a fairly complicated and lengthy process; therefore, it is important to start the preliminary steps toward obtaining funding concurrent with final design. The two most likely mechanisms for funding this project are revenue bonds or a financing agreement with the Clean Water State Revolving Fund (CWSRF). At this time it appears that the CWSRF can save ratepayers several million dollars when compared to bond financing over a 20 year repayment period. The interest rate for CWSRF financing agreements is set at 50% of the most recent general obligation bond rate obtained by the State Treasurer's Office. This is likely to yield a financing cost ranging from 2.5 to 3.5%.

The actions recommended above are the first step in the process of obtaining a CWSRF financing agreement. The attached Resolution incorporates language required by the CWSRF. Staff anticipates returning to your Board for two additional actions prior to finalization of a financial assistance agreement: 1) An Ordinance dedicating a revenue

source for repayment of the borrowed funds; 2) A Reimbursement Resolution indicating the intent of the Agency to comply with Treasury Regulation section 1.150-2 regarding issuance of tax-exempt obligations.

ENVIRONMENTAL CLEARANCE: Approval of the recommended action is not a project as defined in the California Environmental Quality Act; however, the CWSRF will not consider our financial assistance application complete until your Board certifies an environmental document for the Project.

FISCAL IMPACT: Staff estimates that the costs to pursue the CWSRF financial assistance agreement will not exceed \$75,000. Sufficient funds are available in the SMD 1 Wastewater Treatment Plant Upgrade Capital Project budget to cover this expenditure. Approval of this request will have no impact upon the County General Fund.

WHEREAS, Sewer Maintenance District 1 has a need to acquire funding to upgrade
and expand its existing wastewater treatment plant in order to comply with new
discharge standards; and

WHEREAS, State Water Resources Control Board administers the Clean Water State
Revolving Fund program on behalf of the people of the State of California and has
money available for eligible wastewater projects; and

WHEREAS, State Water Resources Control Board requires that, in order to apply for
Clean Water State Revolving Fund financial assistance, the governing Board of the
sewer maintenance district must designate an authorized representative to negotiate
and execute a financial assistance agreement.

NOW BE IT RESOLVED by the Board of Supervisors, County of Placer, State of
California, that the Director of the Department of Facility Services, or his designated
representative, is hereby authorized to sign and file on behalf of Sewer Maintenance
District 1, a Financial Assistance Application for a financing agreement from the State
Water Resources Control Board for the planning, design and construction of the Sewer
Maintenance District 1 Wastewater Treatment Plant Upgrade and Expansion; and

BE IT FURTHER RESOLVED that Sewer Maintenance District 1 hereby agrees and
further does authorize the aforementioned representative or his designee to certify that
the Agency has and will comply with all applicable state and federal statutory and
regulatory requirements related to any financing or financial assistance received from
the State Water Resources Control Board; and

BE IT FURTHER RESOLVED that the Director of Facility Services, or his designee of Sewer
Maintenance District 1, is hereby authorized to negotiate and execute a financial assistance
agreement from the State Water Resources Control Board and any amendment or change
orders thereto upon review and approval by Risk Management and County Counsel, and
certify financing agreement disbursements on behalf of Sewer Maintenance District 1.
