SUBJECT: State Contract for Petroleum Products Compliance/Weighmaster Enforcement Program for Fiscal Year 2010-2011

ACTION REQUESTED: Adopt a Resolution authorizing the Agricultural Commissioner/Sealer to sign contract #10-0046 in the amount of \$6,375 with the California Department of Food and Agriculture for Petroleum Product Compliance, and Weighmaster Enforcement Programs for the Fiscal Year 2010-2011.

BACKGROUND: The California Department of Food and Agriculture (CDFA) provides reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs.

Under this contract, the County will be reimbursed up to a maximum of \$4,875 for activities related to Petroleum product inspections, and \$1,500 for Weighmaster Enforcement Programs for fiscal year 2010-2011.

ENVIRONMENTAL: This activity does not qualify as a project under the California Environmental Quality Act (CEQA)

FISCAL IMPACT: Funding for this contract is in the proposed 10/11 Agricultural Commissioner's budget.
