SUBJECT: State funding for European Grapevine Moth detection trapping March 1, 2010 through June 30, 2010.

ACTION REQUESTED

Adopt a resolution authorizing the Placer County Agricultural Commissioner/Sealer to sign contract #09-0802 with the California Department of Food and Agriculture allowing for reimbursement from the State for up to \$11,033 for costs associated with detection trapping of the European Grapevine Moth in Placer County.

BACKGROUND

The California Department of Food and Agriculture (CDFA) provides for reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs.

This contract will provide funding to the Agricultural Commissioner for placement of up to 40 traps throughout Placer County to detect the presence of the European Grapevine Moth, a pest known to cause extreme injury to many of the agricultural crops grown in Placer County.

ENVIRONMENTAL

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

FISCAL IMPACT

This revenue reimbursement is for an ongoing program and has no impact on the General Fund.
