ACTION REQUESTED / RECOMMENDATION

Adopt a Resolution authorizing the Chairman of the Board of Supervisors to execute the 2010/11 State Transit Assistance (STA) Claim for Tahoe Area Regional Transit in the amount of \$149,166.

BACKGROUND / SUMMARY

Annually, the Tahoe Regional Planning Agency (TRPA) notifies Placer County of the amount of the State Transit Assistance (STA) funds available for allocation in the Lake Tahoe region. TRPA is responsible for regional planning and allocation of these transportation funds in the Tahoe Basin. It is our understanding that the amount of funds available of \$149,166 is intended to cover a two period of FY09/10 and FY10/11

In order for Placer County to receive the funds, it is necessary for your Board to execute a claim requesting the State Transit Assistance funds. Attached for your review and action is a State Transit Assistance Claim in the amount of \$149,166 for submittal to the Tahoe Regional Planning agency on behalf of the Tahoe Area Regional transit System (TART).

ENVIRONMENTAL

The proposed action is not a project as defined by Public Resources Code Section 21065 and is therefore exempt from environmental review under CEQA.

FISCAL IMPACT

The funds will be used for Operations by Tahoe Area Regional Transit and will be budgeted in the Final 2010/11 Fiscal Year Budgets.
