### **ACTION REQUESTED**

Adopt a resolution authorizing the Agricultural Commissioner/Sealer to sign contract #10–0397 with the California Department of Food and Agriculture allowing for reimbursement from the State for up to \$1,840 for Nursery Inspection Program.

### **BACKGROUND**

The California Department of Food and Agriculture (CDFA) provides for reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs.

### **ENVIRONMENTAL**

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

### **FISCAL IMPACT**

This contract provides for \$1,840 in reimbursement to offset the Agriculture Department's impact to the General Fund. Funding for this contract is in the 2010–2011 Agricultural Commissioner's Budget.
