**ACTION REQUESTED**

Approve the award of competitive Bid No. 10022 to Anderson's Sierra Pipe Company of Auburn, California, for plumbing supplies in the maximum aggregate amount of \$98,000.00, and authorize the Purchasing Manager to sign the resulting Blanket Purchase Orders (BPOs).

**BACKGROUND**

On behalf of the Facility Services, Public Works, Emergency Services, and Sheriff's departments, Procurement Services solicited bids for plumbing supplies. A requirement of this bid was that the successful bidder(s) must be located in Auburn. All four local plumbing vendors were notified electronically of Invitation for Bid (IFB) No. 10022, which was also posted on the County's website. The IFB requested inventory size and discounts off manufacturers' list prices.

Anderson's Sierra Pipe submitted the only bid response. Procurement Services determined that Anderson's Sierra Pipe's bid was responsive to the bid requirements and recommends that your Board approve the award of Bid No. 10022 to Anderson's Sierra Pipe.

**FISCAL IMPACT**

The BPOs resulting from this recommendation will be issued in the maximum aggregate amount of \$98,000.00 effective for the period November 2, 2010 through December 31, 2011. The BPO amounts are listed below:
