**ACTION REQUESTED**

Adopt a resolution authorizing the Agricultural Commissioner/Sealer to sign contract #11-0021 for Exotic Pest Detection Trapping with the State Department of Food and Agriculture allowing for reimbursement from the State for up to \$95,615 for enforcing mandated programs.

**BACKGROUND**

The California Department of Food and Agriculture (CDFA) provides for reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs.

**ENVIRONMENTAL**

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

**FISCAL IMPACT**

This contract provides for \$95,615 in reimbursement to offset the Agriculture Department's impact to the General Fund. Funding for this contract is in the 2011/2012 Agricultural Commissioner's Budget.
