SUBJECT: FORESTHILL ROAD RESURFACING/RESTRIPIING PROJECT-
AUTHORIZATION OF AWARD FOR CONSTRUCTION CONTRACT

ACTION REQUESTED / RECOMMENDATION

Adopt a Resolution authorizing the Director of Public Works to award and execute the construction contract for the Foresthill Road Resurfacing/Restriping Project to the lowest responsible and responsive bidder up to an amount of \$77,000, with County Counsel and Risk Management review and approval, and authorize the Director of Public Works to execute contract change orders up to an amount of \$10,000.

BACKGROUND / SUMMARY

On Foresthill Road between post mile 5.25 and 5.50, the Department of Public Works is proposing to improve the road by restriping the centerline and extending the westbound passing lane by approximately 400 feet in order to improve safety.

The project is being completed under the American Reinvestment and Recovery Act (ARRA). Timing for this project is critical, as the department would like to have this project substantially complete before winter storms commence.

Bids for this project were opened on May 24, 2011. Three (3) bids were received. The apparent low bidder appears to be California Pavement Maintenance of Sacramento. In order to complete work this summer, the Department is requesting authorization from the Board for the Director of Public Works to award the contract to the lowest responsible and responsive bidder.

ENVIRONMENTAL

This action is categorically exempt pursuant to Section 15301(c) of the CEQA guidelines, Operation of Existing Streets and Highways.

FISCAL IMPACT

The project will be funded with federal funds from the American Reinvestment and Recovery Act (ARRA) and the Foresthill traffic impact fees. Funding for the project is included in the FY 2010/2011 Budget.


