ACTION REQUESTED / RECOMMENDATION

Adopt a Resolution accepting the Dollar Point Bus Shelter as complete and approving and authorizing the Director of Public Works to execute the Notice of Completion.

BACKGROUND / SUMMARY

The Dollar Point Bus Shelter is located on the north side of Highway 28, near the intersection of Dollar Drive and Highway 28, just east of Tahoe City.

On May 24, 2011, the Board of Supervisors authorized the Department of Public Works to advertise for bids and allow the Public Works Director to execute a contract to construct a bus shelter. The contract was executed with Orlando Enterprises Tahoe, Inc., of Carnelian Bay, California on June 23, 2011, and work was completed on September 16, 2011.

ENVIRONMENTAL

This project is categorically exempt from the provisions of CEQA under the following sections: Section 15301, Existing Facilities, Class 1; Section 15303, New Construction or Conversion of Small Structures Class 3.

FISCAL IMPACT

The contract was awarded for \$50,954 with a contingency of \$5,095. The final estimated cost of \$50,954 has been determined by this department. There were no Contract Change Orders issued during the project. A contract data and change order summary is attached as Exhibit A. The project is fully funded through traffic mitigation fees. Funding for the construction of this project is included in the 2011-12 Fiscal Year Budget.




