Subject: State Farm 2013 Good Neighbor Citizenship Grant

Action Requested

1. Approve a Budget Revision to increase revenue and expenditures in the amount of \$15,000 received from the State Farm Insurance Companies Good Neighbor Citizenship Grant. Funding is for the Sheriff's Office In-Car Camera Project for FY 2012-13.
2. Authorize the Purchasing Manager to execute all related documents.
3. Add the equipment to the Master Fixed Asset List.

Background

On February 13, 2013 the Sheriff's Office received notification that they had been selected to receive the State Farm Insurance Companies Good Neighbor Citizenship Grant in the amount of \$15,000. Grant funds will be utilized to benefit the motoring public by contributing towards the costs of the Sheriff's In-Car Camera Project. The In-Car Camera project increases officer safety; promotes driver and passenger safety through enforcement of traffic laws; documents traffic incidents and increases the likelihood of successful prosecution

Fiscal Impact

Funds in the amount of \$15,000 from this grant will be added to the Sheriff's FY 2012-13 Information Technology Budget. There is no additional fiscal impact to the General Fund.
