ACTION REQUESTED

Introduction of an uncodified ordinance to revise the salary plan and grade for the Director of Air Pollution Control.

BACKGROUND

On August 8, 2013, the Placer County Air Pollution Control District Board of Directors approved a salary increase of approximately 8% for the classification of Director of Air Pollution Control (APCO). The attached proposed ordinance represents the salary documents required to implement the new Salary Administration Plan and associated grade in the County payroll system to provide the APCO with an approximate 8% increase in salary. This proposed ordinance is presented to your Board for review and approval.
