

SUBJECT: DIAL-A-RIDE CONTRACT 20543, AMENDMENT NO. 9, AND CONTRACT 12530, AMENDMENT NO. 7, FY 2013-14

ACTION REQUESTED / RECOMMENDATION

1. Adopt a Resolution authorizing the Director of Public Works to execute, with County Counsel and Risk Management's review and approval, Amendment No. 9 to Contract No. 20543, in an amount not to exceed \$94,403, and Amendment No. 7 to Contract No. 12530, in an amount not to exceed \$145,231, with PRIDE Industries for a total amount of \$239,634 for month-to-month extensions for up to three months to operate Highway 49 Dial-A-Ride and South Placer Dial-A-Ride through December 31, 2013. There is no net County cost.

BACKGROUND / SUMMARY

PRIDE Industries operates the Dial-A-Ride service under two multi-year contracts with Placer County. The Highway 49 Dial-A-Ride provides demand response transit service in the Highway 49 corridor between Dry Creek Road and downtown Auburn. The South Placer Dial-A-Ride provides 1) Dial-A-Ride service in the Loomis and Rocklin area; 2) Dial-A-Ride service in Granite Bay; and, 3) a deviated route shuttle on Taylor Road between Auburn and Sierra College. Dial-A-Ride meets requirements of the Americans with Disabilities Act (ADA). The Highway 49 Contract (20543) was approved in August of 2004, and the South Placer Dial-A-Ride Contract (12530) was approved in January of 2008. On August 20, 2013, your Board approved Agreement #1159 with MV Transportation for the provision of Dial-A-Ride services. As MV Transportation is a new contractor, the Department of Public Works (DPW) is requesting this extension to provide for a smooth and seamless transition between contractors. DPW anticipates the new contractor MV Transportation to be in place and operational by November 1, 2013.

The proposed charge from PRIDE Industries for both contract amendments in FY 2013-14 is \$58.09 per service hour for a total of \$239,634, which is consistent with the current fiscal year. This includes drivers, vehicle maintenance, reservations, dispatchers and administration. DPW believes this is a reasonable charge compared to other nearby contracted services and the County costs. All other contract provisions will remain the same as in the original contract. In accordance with the Purchasing Policy Manual, Section 1.3(o), County policy allows for the renewal of a contract based on the satisfactory service and reasonable pricing from the vendor.

ENVIRONMENTAL

The project is statutorily exempt from CEQA pursuant to section 21080(b)(10), as it is a project to provide passenger service.

FISCAL IMPACT

The \$239,634 maximum cost of the Dial-A-Ride Contracts for the second quarter of FY 2013-14 is included in the proposed Placer County Transit Budget. These Contracts are funded by City contributions, County Transportation Development Act funds and FTA 5307 funds.
