**BACKGROUND/COMMUNITY BENEFITS**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to Placer Union High School District for upgrades to the Placer High School Athletic Complex. A major project is underway in an effort to upgrade the Placer High School's Track and Field. The State Modernization Funds for educational facilities has been exhausted. Placer's operating budget currently cannot support capital expenditures of this nature. The project will have several phases and will include replacement of the forty-five year old stadium lights and the extension and improvement of public access walkways. This facility serves 1,350 students in an active and diverse schedule of eighteen different sports. Each year the track and field serves as the "finish line" for the world's famous Western States 100 Mile Endurance Run. In addition, the complex is home to youth soccer, Pee Wee and Junior Hillman Football teams, families and individuals who come daily to play tennis, exercise, run laps and just enjoy the outdoors. Funding received will go toward the purchase of the replacement stadium and walkway light fixtures.
