SUBJECT: Professional Consulting Services for Public Works Projects in Eastern Placer
County – Qualified Lists

ACTION REQUESTED

1. Approve a one-year extension of four Qualified Lists of firms for professional consulting services for public works projects in Eastern Placer County, as the result of competitive Request for Qualifications No. 10017, for the period of March 1, 2014 through February 28, 2015.

BACKGROUND

On February 22, 2011, your Board approved the award of competitive Request for Qualifications (RFQ) No. 10017. As a result, four separate Qualified Lists for four categories of professional consulting services were adopted for the period of March 1, 2011 through February 28, 2014. The Qualified Lists showing the approved firms are attached.

The four categories of various professional services identified in the RFQ include civil engineering design; surveying; revegetation design and inspection; and environmental analysis and documentation. These services are requested by the Department of Public Works (DPW) on an as-needed basis.

Based on the positive response from DPW, Procurement Services recommends exercising the first renewal option, extending the Qualified Lists through February 28, 2015.

FISCAL IMPACT

There is no immediate fiscal impact resulting from this action. Individual contracts will be negotiated with one or more firms as needed, and the resulting expenditures will be funded from existing budgets or project funds, as appropriate. Contracts of \$50,000 or less may be executed by the Purchasing Manager. Contracts which are greater than \$50,000 will require your Board's approval.
