Subject: Ordinance Amending the Placer County Code to Include Sewer Maintenance District 3 and the Dry Creek Sewer County Service Area under City of Roseville Sewer Regulations

---

**ACTION REQUESTED:**

1. Adopt an Ordinance amending Placer County Code Sections 13.12.240 (H) "Charges", and 13.12.410 (A) "Applicability of City of Roseville Sewer Regulations" to include Sewer Maintenance District 3 (Horseshoe Bar) and the Dry Creek Sewer County Service Area at no net County cost.

**BACKGROUND:** Sewer Maintenance District (SMD) 3 provides sewer service to approximately 615 equivalent dwelling units in the Horseshoe Bar area. In April 2013, your Board awarded the construction bid for the SMD 3 Regional Sewer Project (Project) which includes construction of a pump station at the existing SMD 3 treatment plant site, and installation of a regional pipeline that will convey flows to the City of Roseville for treatment at its regional wastewater treatment plants (Regional Facilities). The Project is under construction and scheduled to be operational by November 2014.

Our agreements with the South Placer Wastewater Authority require the County to adopt Roseville's regulations regarding sewer usage for those districts utilizing the Regional Facilities. With completion of the Project, it is necessary to revise the districts listed in the Placer County Code subject to Roseville's regulations to include SMD 3. Additionally, County Service Area No. 28, Zone 173 – Dry Creek, currently flows to Roseville, but was previously inadvertently omitted from the listed sewer districts. The attached Ordinance amends the Placer County Code to include both districts. The attached Ordinance also deletes an erroneous reference to Roseville City Code Section 14.16.200 which deals with maintenance and operations fees.

**ENVIRONMENTAL CLEARANCE:** The above action is not a project as defined in the California Environmental Quality Act.

**FISCAL IMPACT:** Amending the Ordinance to include SMD 3 and the Dry Creek County Service Area under Roseville's sewer regulations will have no net County cost.

## THE BOARD OF SUPERVISORS OF THE COUNTY OF PLACER, STATE OF CALIFORNIA, DOES HEREBY ORDAIN as follows:

**Section 1:** Subsection (H) of Section 13.12.240 Charges, of Chapter 13 of the Placer  
County Code is hereby amended to read as follows:

- H. For the purpose of calculating the amount of the connection fee and the sewer service charge for a property within sewer maintenance district No. 2, **sewer maintenance district No. 3**, and county service area No. 28, zones of benefit Nos. 2, A3, **173**, and 55, the quantity of sewage flow from the various types of establishments shall be conclusively presumed to be as set forth in Section 14.16.100, ~~14.16.200~~, 14.16.230 and 14.16.240 of the Roseville City Code, as adjusted from time-to-time by the city of Roseville, which regulations are incorporated by referenced into this article. A copy of

the referenced provisions of the Roseville City Code shall be kept available for public inspection by the director and in the office of the clerk of the board of supervisors. (Ord. 5059-B § 20, 2000; prior code § 18.27)

**Section 2:** Subsection (A) of Section 13.12.410 Applicability of city of Roseville sewer regulations.

A. In addition to all regulations set forth in this chapter, each user of the county sewer system within Placer County sewer maintenance district No. 2, **sewer maintenance district No. 3,** county service area No. 28, Zone No. 2, A3, county service area No. 28, Zone No. 55 and county service area No. 28, Zone No. 173 shall comply with the following regulations of the Roseville City Code in effect as of December 1, 2006, and which are adopted and incorporated into this chapter by reference:

1. Section 14.12.050, Use of Public Sewers;
2. Chapter 14.17, Recycled Water Service.

**Section 3:** This Ordinance shall take effect and be in full force and effect sixty (60) days after its passage. The Clerk is directed to publish this Ordinance, or a summary thereof, within fifteen (15) days in accordance with Government Code Section 25124.
