**Subject:** Accept the Alcohol & Drug Impaired Driver Vertical Prosecution Grant

## ACTION REQUESTED

1. Approve an agreement authorizing the District Attorney, to sign the Grant Award Agreement for the Alcohol and Drug Impaired Driver Vertical Prosecution Program Grant in the amount of \$332,462 from October 1, 2014 to September 30, 2015.
2. Approve a Budget Revision in the amount of \$332,462 to increase revenue and expenditures for the acceptance of the Grant Award Agreement.

## BACKGROUND

The District Attorney's Office has been awarded funding by the Alcohol and Drug Impaired Driver Vertical Prosecution Program Grant, administered by California's Office of Traffic Safety. This Agreement will allow the District Attorney's Office to assign a specialized team to prosecute alcohol and drug impaired driving cases. The Driving Under the Influence (DUI) prosecution team will handle cases throughout each step of the criminal process. Prosecution team members will work with the Traffic Safety Resource Prosecutor Program to increase the capabilities of the team and the office by obtaining and delivering specialized training. Team members will share information with peers and law enforcement personnel throughout the county and across the state. The office will accomplish these objectives as a means to prevent impaired driving and reduce alcohol and drug-involved traffic fatalities and injuries.

Acceptance of this grant offers financial support for one Deputy District Attorney, one District Attorney Investigator and travel/training expenses for a period of 12 months. The Deputy District Attorney will work closely with the District Attorney Investigator to address emerging defense strategies and conduct outreach efforts designed to increase awareness of alcohol-related injuries and deaths. The grant includes non-supplanting language so that currently funded positions cannot be used on behalf of this. There are positions allocated within the District Attorney's Office that are not funded at this time.

## FISCAL IMPACT

This grant award allocates funding with Federal monies for one year in the amount of \$332,462. No General Fund dollars will be applied to this grant program.


