**BACKGROUND/COMMUNITY BENEFITS**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help support the Placer Land Trust's *10<sup>th</sup> Annual Placer Conservator Award Ceremony*, to be held on October 23<sup>rd</sup>. Since inception in 1991, the Placer Land Trust has evolved into a premiere non-profit organization protecting Placer County's wide open wonders, natural playgrounds, and the quality of life for current and future generations. Each year Placer Land Trust presents the Placer Conservator Award to an individual, or organization that enriches the quality of life in Placer County through resource conservation. This year's honoree at the award ceremony is the Auburn State Recreation Area Canyon Keepers (ASRACK), a volunteer group that promotes healthy recreation by providing assistance and information for visitors to the state park. The ASRACK organizes hikes, conducts trail maintenance, provides guided history walks, and assists the professional ranger staff through volunteer work. The Revenue Sharing funding received will help defray costs for the *Annual Placer Conservator Award Ceremony*. Proceeds from the event go directly toward Placer Land Trust's efforts to work with willing landowners and conservation partners, including Placer County, to permanently protect natural and agricultural land in Placer County.
