BACKGROUND/COMMUNITY BENEFITS

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to The Bucks Booster Club, for the student originated *Alta Vista Community Charter School Kitchen Project Fundraiser*. As one of the oldest schools in Auburn, the recently reopened Alta Vista Community Charter School (AVCCS) serves students from kindergarten through the fifth grade. Fifty-one percent of these students have been designated as low income. More than 100-years old, the AVCCS lacks the professional grade equipment needed to cook for its students. Ten year old AVCCS student Mason Partak has been one of the driving forces in the fundraising efforts to raise \$25,000 for the purchase of new professional grade kitchen appliances for AVCCS kitchen. To date, Mason Partak has raised over \$19,000. The funding received will go directly toward the purchase of the new kitchen appliances for Alta Vista Community Charter School.
