Subject: Board of State and Community Corrections, Edward Byrne Memorial Justice Assistance Grant (JAG) Program

Action Requested

1. Adopt a Resolution authorizing the Sheriff to execute the grant award from the Edward Byrne Memorial Justice Assistance Grant administered by the Board of State and Community Corrections.
2. Approve a Budget Revision increasing revenues and expenditures for the Grant amount of \$715,000 for FY 2014-15, from March 1, 2015 through December 31, 2015.

Background

The Placer County Sheriff's Office, in collaboration with Sierra Native Alliance, Latino Leadership Council, Placer County Health and Human Services, and the Placer County District Attorney's Office, will utilize Justice Assistance Grant program funding through the Trauma Informed Response (TIR) project to provide programs for drug related substance abuse and mental health, trauma response, and law enforcement services to the communities of Placer County. Funding from the Grant is projected to cover all costs associated with the TIR project goals, including staff, training, professional services, data collection, and reporting.

Fiscal Impact

Upon Board approval, revenues and expenditures in the amount of \$715,000 will be added to the Sheriff's Office FY 2014-15 Final Budget. There is no additional impact to the General Fund.
