SUBJECT: PURCHASE OF A REPLACEMENT PRESSURE WASHER FOR TAHOE AREA REGIONAL TRANSIT

ACTION REQUESTED / RECOMMENDATION

1. Adopt a Resolution approving a Budget Revision to add \$7,200 to the Fiscal Year 2014-15 Department of Public Works Tahoe Area Regional Transit (TART) Budget to replace a pressure washer at TART.
2. Amend the Master Fixed Asset List for Fiscal Year 2014-15 to add a pressure washer at TART

BACKGROUND / SUMMARY

The TART facility in Truckee is in need of a new industrial pressure washer. The existing pressure washer is a stationary 2000psi pressure washer with heated water that was installed in the bus wash bay as part of the original construction when the TART facility was built in 1999. The pressure washer is used on a daily basis to wash the TART fleet. It is also used by Fleet Services to degrease equipment prior to maintenance. Over the past several years, DPW/Transit Services has spent an increasing amount of money to repair and keep the existing pressure washer operational. The pressure washer is now in need of full replacement

ENVIRONMENTAL

The project is categorically exempt from CEQA pursuant to section 15301, as it is an existing facility.

FISCAL IMPACT

Sufficient funds are available in reserves in the TART appropriation to cover the \$7,200 cost of the replacement pressure washer.


