SUBJECT: Approve a Proclamation Declaring August 2015 as Child Support Awareness Month in Placer County.

ACTION REQUESTED

Approve the attached Proclamation declaring August 2015 as Child Support Awareness Month in Placer County.

BACKGROUND

Since 2009, your Board has recognized the month of August as "Child Support Awareness Month" in Placer County. This Board's support of August as "Child Support Awareness Month" continues to assist the Placer County Department of Child Support Services in promoting positive relationships by providing support services that: Enhance stability; while ensuring parents pay child support on a regular and timely basis. Children are the most valuable resource, and need the emotional, medical, and financial support of each parent in order to reach their full potential as adults.

More than 8,000 local California child support professionals are steadfastly committed to improving the quality of life for 1.2 million California children and families through timely, accurate, and responsive child support services; which collected over \$2.3 billion last year, including over \$22 million by the Department of Child Support Services of Placer County. As with this Board, the State of California formally recognizes the month of August as "Child Support Awareness Month" by proclamation from the Office of the Governor.

WHEREAS, more than 8,000 local California child support professionals are steadfastly committed to improving the quality of life for 1.2 million California children and families through timely, accurate, and responsive child support services; which collected over \$2.3 billion last year, including over \$22 million by the Department of Child Support Services of Placer County; and

WHEREAS, these crucial payments not only fulfill a legal responsibility, but they also reduce the need for public assistance, and provide everyday necessities such as food, clothing, shelter, and medical care; and

WHEREAS, increasing public awareness of the importance of this issue through education, outreach, and media attention will reinforce the position that all parents must take responsibility for the financial, emotional, and physical support of their children; and

NOW, THEREFORE, BE IT PROCLAIMED THAT the Placer County Board of Supervisors does hereby declare August 2015 as “Child Support Awareness Month” in Placer County in support of the State of California designating August as “Child Support Awareness Month”.
