**BACKGROUND/COMMUNITY BENEFITS**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to Placer High School for their track and field improvements. Currently the track is used for the student's football and track programs. After school hours, the track area benefits the public as an area for walking, running, and recreational activities. The school hopes the improvements will bring back community interest in youth football, the Western States Race, and the return of old and new community events that require the use of the track and field. Funding received will be used to help pay for the resurfacing of the track, new runways for the long and triple jump, a new shot put arena and renovation of the pole vault and high jump areas.


