**Action Requested**

1. Adopt a Resolution authorizing the Sheriff to execute a grant award from the Department of Parks and Recreation Division of Boating and Waterways for FY 2015-16 in the amount of \$82,295 for the Sheriff's Marine Patrol Program. The grant period is from October 1, 2015 through June 30, 2016.
2. Approve a Budget Revision to increase revenue and expenditures in the amount of \$82,295 for special department expense, and authorize the Purchasing Manager to execute all related documents.

**Background**

On August 17, 2015 the Sheriff's Office received notification that an equipment grant application for FY 2015-16 had been awarded by the Division of Boating and Waterways. Grant funds will be utilized for specific equipment to support our boating safety enforcement program.

**Fiscal Impact**

Upon approval, \$82,295 will be added to the Sheriff's Office FY 2015-16 Budget. There is no additional fiscal impact to the General Fund.
