SUBJECT: Adopting FY 2015-16 Property Tax Rates for Voter-Approved Indebtedness

Action Requested/Recommendation

Adopt a resolution approving the FY 2015-16 property tax rates for voter-approved indebtedness, pursuant to Government Code sections 29100 and 29106.

Background

Annually, tax rates are levied on the current secured property tax roll for voter-approved indebtedness, pursuant to Government Code sections 29100 and 29106. Rates are levied to pay the principal and interest due to the bondholders of these general obligation bonds. The rates are determined by computations of the annual debt service requirements, the available financing and the assessed valuations.

Fiscal Impact

There is no cost to the County. These debt service rates are levied primarily for school bonds, but are also required for some city and district bonds, as shown on the attached.
