**WHEREAS**, an Offer of Dedication was made to the public for the onsite roadways within the Cambridge Estates Subdivision, identified as Lot A and recorded as the Whitebridge Estates Subdivision in Book Z of Maps at Page 89; and

**WHEREAS**, it has been determined that the offer of dedication for Lot A, not accepted at the time the Whitebridge Estates Subdivision was recorded, and as described on the attached Exhibit "A" and as shown on the attached Exhibit "B", is no longer necessary for present or prospective public use; and

**WHEREAS**, summary vacation of the Offer of Dedication is permissible pursuant to Chapter 4 of Part 3, Division 9 of the Streets and Highways Code, commencing with Section 8330.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of Placer County that from and after the date this Resolution is recorded, the Offer of Dedication for the onsite roadways within the Cambridge Estates Subdivision, as described on the attached Exhibit "A" and as shown on the attached Exhibit "B", shall be vacated and abandoned, and shall thereafter not constitute an Offer of Dedication for a public road; and

**BE IT FURTHER RESOLVED** by the Board of Supervisors of Placer County that the above described Offer of Dedication, as described and shown on the attached exhibits, is not useful as a nonmotorized transportation facility.

This Resolution of Abandonment shall have no effect on the Offer of Dedication for King Road, offered and accepted on the map of Whitebridge Estates, filed for record in Book Z of Maps at Page 89.

**LEGAL DESCRIPTION**




