
The following RESOLUTION was duly passed by the Board of Supervisors

WHEREAS, Sequoia Avenue was dedicated to and accepted by Placer County on the Amended Map of Lake Tahoe Park, filed for record in Book D of Maps at Page 17; and

WHEREAS, a portion of the Sequoia Avenue physical roadway is not located within the easement created on D of Maps at Page 17; and


WHEREAS, it has been determined that the portion of Sequoia Avenue not within the existing easement, as described on the attached Exhibits "A" thru "D", is no longer necessary for present or prospective public use; and

WHEREAS, a new Offer of Dedication for a Highway Easement will be recorded to encompass the existing, physical road improvements; and

WHEREAS, summary vacation of the Sequoia Avenue easement is permissible pursuant to Chapter 4 of Part 3, Division 9 of the Streets and Highways Code, commencing with Section 8330.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Placer County that from and after the date this Resolution is recorded, the portion of Sequoia Avenue, as described on the attached Exhibits "A" thru "D", shall be vacated and abandoned, and shall thereafter not constitute an easement for its intended purpose; and



LEGAL DESCRIPTION

SEQUOIA AVENUE ABANDONMENT

LAKE TAHOE PARK ASSOCIATION TRUSTEE

All that portion of Sequoia Avenue shown as "County Road" on the Amended Map of Lake Tahoe Park Subdivision No.1 recorded May 8, 1926 in Book "D" of Maps, at Page 17 of Placer County Official Records, State of California, situate within a portion of the Southeast one-quarter (SE ¼) of Section 13, Township 15 North, Range 16 East, Mount Diablo Meridian, more particularly described as follows:

Commencing at the Southeast Corner of Block "S" of said Amended Map of Lake Tahoe Park Subdivision No.1; thence on the Westerly line of said Sequoia Avenue, South 05°48'00" West 215.91 feet to a point on the South Section Line of said Section 13, from which a witness meander corner marked by a 2 inch iron pipe with brass cap stamped "General Land Office Survey 1926 Sections 13 and 24, T.15 N., R. 16 E., W.C. and M.C., bears South 89°38'00" East 143.50 feet; thence leaving said Westerly line South 89°38'00" East on said Section Line 40.18 feet to a point on the Easterly line of said Sequoia Avenue; thence leaving said Section Line North 05°48'00" East on the said Easterly line 44.20 feet to a point on the Northerly line of the real property in favor of the Tahoe City Public Utility District, recorded May 8, 1969 described in Book 1243 Official Records at Page 273 of said Placer County, said point being the True Point of Beginning (TPOB); thence from the (TPOB), leaving said Easterly line North 89°38'00" West on said Northerly line 28.50 feet to the Northwest corner of said Tahoe City Public Utility District parcel; thence leaving said parcel, North 11°45'36" East 114.56 feet; thence North 23°56'30" East 52.91 feet to a point on the Easterly line of said Sequoia Avenue; thence South 05°48'00" West on the said Easterly line 161.52 feet to the True Point of Beginning (TPOB), containing 0.0673 acres more or less.

The Basis of Bearings for the above descriptions is – The South Section Line of Section 13, Township 15 North, Range 16 East, Mount Diablo Meridian taken to be South 89°38'00" East.







All that portion of Sequoia Avenue shown as "County Road" on the Amended Map of Lake Tahoe Park Subdivision No.1 recorded May 8, 1926 in Book "D" of Maps, at Page 17 of Placer County Official Records, State of California, situate within a portion of the Southeast one-quarter (SE ¼) of Section 13, Township 15 North, Range 16 East, Mount Diablo Meridian, more particularly described as follows:

Commencing at the Southeast Corner of Block "S" of said Amended Map of Lake Tahoe Park Subdivision No.1; thence on the Westerly line of said Sequoia Avenue, South 05°48'00" West 215.91 feet to a point on the South Section Line of said Section 13; thence leaving said Westerly line South 89°38'00" East on said Section Line 7.00 feet to the Southwest corner of the real property in favor of the Tahoe City Public Utility District, recorded May 8, 1969 described in Book 1243 Official Records at Page 273 of said Placer County, said Southwest corner being the True Point of Beginning (TPOB), from which a witness meander corner marked by a 2 inch iron pipe with brass cap stamped "General Land Office Survey 1926 Sections 13 and 24 T.15 N., R. 16 E., W.C. and M.C., bears South 89°38'00" East 136.50 feet; thence from the (TPOB), continuing on said Section Line South 89°38'00" East 33.18 feet to a point on the Easterly line of said Sequoia Avenue; thence leaving said Section Line North 05°48'00" East on the said Easterly line 44.20 feet to a point on the Northerly line of said Tahoe City Public Utility District parcel; thence leaving said Easterly line North 89°38'00" West on said Northerly line 28.50 feet to the Northwest corner of said parcel; thence South 11°45'36" West 44.88 feet to the True Point of Beginning (TPOB), containing 0.0312 acres more or less.


