SUBJECT: REVENUE SHARING – Placer County Council, Navy League to fund a community program so it can continue.

ACTION REQUESTED

Approve appropriation of \$750 in Revenue Sharing monies to Placer County Council, Navy League for EV Cain's SeaPerch Project as requested by Supervisor Holmes (\$750) to purchase additional kits and accessories to continue the program and possibly expand the program to include other community schools.

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to Placer County Council, Navy League for EV Cain's SeaPerch Project. The school is using this project to get students to enthusiastically work as a team to build underwater submersible vehicles that they will test in a local pool. The project uses science, technology, engineering and math to plan, construct, troubleshoot and then operate. The funds received will enable the council to purchase additional SeaPerch kits and accessories to continue the program and possibly expand the program to include other community schools.
